Part IV - Carry-forward Adjustment

2019-20 Budget Assumptions

The SoCal ROC Board approved the 2019-20 budget in May 2019 for both revenue and expenditures.

Fund 1 - Revenue

Carl Perkins

Carl Perkins allocation was budgeted for 2019-20 at \$19,125.

CTEIG Grant – Resource 06870.0

SoCal ROC did not receive any CTEIG funding for 2019-20. This will be a significant reduction in the ending fund balance.

Resource 06350

We are anticipating a decrease in revenue for SoCal ROC's "Pay for Play" funding model due to decrease in enrollments. SoCal ROC will receive approximately \$970,000 from the districts.

Adult Fees

Monies received from adults paying for fee-based classes are an additional funding source. Adult fees were budgeted at \$800,000 in the Board approved budget in May 2019. SoCal ROC has projected \$900,000 in adult fee revenue for 2020-21 and for 2021-22.

Lease payments

SoCal ROC leases a portion of the property to Honda. Lease payments in the amount of \$300,000 have been included in the 2019-20 budget.

CalWorks

SoCal ROC has projected to receive \$19,000 in Cal Works funding for 2019-20. This amount is included in the budget

Multiyear Projections

The Multiyear Projections for 2019-20 shows revenue totaling \$4,726,267 and expenditures totaling \$5,206,071. In 2020-21 and 2021-22 of the multi-year projections, SoCal ROC shows budgets of:

2020 – 21

Revenues: \$4,428,485
Expenditures: \$5, 901,734

2021 – 22

Revenues: \$3,428,485
Expenditures: \$5, 901,734

Due to anticipated decreases in revenue, SoCal ROC will be deficit spending from reserves.

Fund 1 - Expenditures

Salaries

Salaries (both certificated and classified) have been budgeted at \$3,257,021 in the May 2019 Board approved budget. The same amount has been budgeted for 2020-21 and 2021-22.

Benefits

Benefits have been budgeted at \$606,180 in the May 2019 Board approved budget. The same amount has been budgeted for 2020-21 and 2021-22. Insurance costs are adjusted based on information received from insurance carriers and on the amount projected for retiree benefits. This information is reviewed on an annual basis.

Supplies

Supplies have been budgeted at \$326,626 in the May 2019 Board approved budget. This is an increase of \$62,551 from 2018-19. The same amount has been budgeted for 2020-21 and 2021-22.

Services & Other Operating Expenses

Services and Other Operating Expenses have been budgeted at \$1,000,907 for the 2019-2020 year. This is a decrease of over \$183,000 from the 2018-219 budgeted amount.

Fund 14 – Deferred Maintenance

The Board approved budget includes \$100,000 to spend out of Fund 14 for Deferred Maintenance in 2019-20. Zero dollars have been projected for 2020-21 and 2021-22.

Fund 40 – Capital Outlay

The Board approved budget includes \$200,000 to spend out of Fund 40 in 2019-20. Zero dollars have been projected for 2020-21 and 2021-22.
