Opportunity to Serve as a Member of the SoCal ROC Governing Board

- The Southern California Regional Occupational Center is seeking one interested and qualified individual to serve as member of the current Governing Board in the capacity of Board Member-at-Large. **This is a volunteer position.** The Southern California Regional Occupational Center provides Career Technical Education programs to over 9,000 high school students and adults annually in the South Bay. SoCal ROC has a rich, forty-seven year history as a Career Technical Education provider, being the first of seventy-two ROC/Ps established in the State of California.
- Board Members-at-Large focus on specific programs and activities at the SoCal ROC Center, representing high school students who are not part of the JPA school districts and the hundreds of adults served through Center programs. Other duties and responsibilities may include: serving on the Center's self-study teams for WASC accreditation process; serving as an advocate for Career Technical Education locally and throughout the State; and helping to establish a network of stakeholders including legislators, community leaders, and educators to promote and expand Career Technical Education opportunities to high school students and adults throughout the South Bay.
- Board Members-at-Large are considered regular voting members of the current SoCal ROC Board of Education. Two of the eight Board seats are designated as Board Members-at-Large. The SoCal ROC Board of Education will select the successful candidate to fill this seat.

In order to be considered for the position Board Member-at-Large, candidates must:

- Complete and submit a completed application by the deadline
- Verify experience as a Board Member on a public school board within California or board members from other educational organization; i.e. Education Foundations; private schools; charter schools; or Community College. Note: candidates may not be "current" members of an approved board as listed above
- Demonstrate evidence regarding knowledge of Career Technical Education
- Verify experience in advocacy within the area of Career Technical Education
- Reside in one of the attendance areas of the school districts that are part of the SoCal ROC JPA:

Selection Process

- Successful candidates will be interviewed by the SoCal ROC Board of Education at a
 regular scheduled meeting of the SoCal Board of Education in June at a date to be
 determined. Interviews will be conducted during the public meeting.
- One successful candidate will be selected by the SoCal ROC Board to fill the Board Member-at-Large Seat.
- Term of appointment will begin July 1, 2017 through June 30, 2019.
