SoCal ROC Director of Student Support Services/Programs, Atlas Helaire, briefed

the Board an overview of the SoCal ROC Cosmetology program. Mr. Helaire reported that the Cosmetology program was restructured during the summer and early fall. The course outlines, lesson plans, and syllabus were revised to accommodate the 1,600 hours into eight modules: Cosmetology Module I, II, III, IV, V, VI, VII, and VIII.

Mr. Helaire introduced Cosmetology instructor Tina Kotch to the Board. Ms. Kotch explained that during the first nine-week module, Cosmetology Module I, students complete 108 hours out of the 1,600 hours of training needed for the California Board of Barbering and Cosmetology License. Students learn to master theoretical and practical applications in cutting, straightening, braiding, styling, tinting and bleaching of hair, wigs, and hairpieces. Students also learn basic skills in manicuring, facials, safety measures, and proper disinfecting techniques.

Mr. Helaire also introduced Cosmetology students Allyson Cunningham, a North High School senior and Malarie Davis, a North High School junior, to the Board. Ms. Cunningham expressed that she would like become a make-up and hair artist in the entertainment industry when she completes the SoCal ROC Cosmetology program. Ms. Davis shared that her family owns and operates a barber shop. She plans to work at the family business when she earns her Cosmetology license. Ms. Davis said that she also has a passion for the medical field, but is also interested in owning a spa.

Board President Barbara Lucky presented SoCal ROC Cosmetology Instructors Tina Kotch and Shawn Bates, each a Board Certificate of Excellence.
